Subject : Annual Fees by Members and Clients – Moratorium till May 31, 2020.

Dear Member(s),

Power Exchange India Limited (PXIL), India's first institutional power exchange, has been providing uninterrupted services to all its Members and Clients during the current unprecedented situation due to outbreak of Corona virus (COVID 19). PXIL is committed to continue to support its Members and Clients and to provide assistance in alleviating the difficulties imposed due to the pandemic.

Vide Exchange Circular no 290 dated April 6, 2020 - Annual Fees by Members and Clients – a moratorium was granted till April 30, 2020 for deposit of Annual Fees by Members and Clients.

The moratorium to deposit the Annual Fees by Members and Clients is hereby extended till May 31, 2020. The moratorium is applicable to all our Members and Clients whose Annual fees payment was due between March 01, 2020 and May 31, 2020. During this period the Members and Clients shall remain active and enabled in 'PRATYAY'. However, their annual fees will be reckoned from the original date it was due for payment.

Example: *A member/client had paid Annual fees on March 10, 2019 then his payment was valid till March 09, 2020, before March 10, 2020 he has to make payment of Annual fees, but now he can pay the Annual fees any time before May 31, 2020, the annual fees such paid will be in effect from March 10, 2020 which is the original date for payment*
